## *Editor's Notes—Dorothy S. Blaner '72*

*What motivates you? During the month of March, it seems like everyone is excited to see college teams participate in "March Madness". We find basketball exciting. When it gets down to the final four teams, we check rankings and hopefully predict the winning team. What makes them successful? Did they have a game plan? Did their coach use a certain method to inspire them?*

*As THS Alumni, we had the opportunity to choose our own path to success. We selected academic classes, scheduled required subject areas and included extracurricular sports, band, baseball, football, tennis, golf, basketball, track etc. Now, back to our original question—what motivated you? Successful people have told us that the single most important item that made them the winners they are was a result of —EDUCATION. Education has allowed them to determine their path to greatness.*

*Toronto High School has been the home to many fine athletes and many successful individuals. Be proud of your school, especially if you are a graduate of the class of 1992, whose THS varsity basketball team was OVAC champions and recorded more wins (19) than any other in THS history since the 20 game regular season started. Members of that team included seniors Otis Winston, Ryan Winstel, Aaron Clegg, Bob Haynes, Tim and Tom Anderson. The team was coached by John Tice, who stated (during the Red Knight Women's Club winter sports*

*banquet) those seniors were "some of the best ever athletes". To quote John Enrietto, former sports editor of the Herald Star, the 1991-92 Toronto basketball team was a "hardworking scrappy team, a team full of long arms and lean bodies, capable of swatting away passes and turning them into turnovers, quick transition and easy buckets the other way". He went on to say, "Toronto outscored its opponents by an average of 74.7—66.6 each game. That's an average of 19 points; they won nine games by 20 or more points, 5 others by margins of 30 or more. The Red Knights had 71 three-point goals that year, well over 3 per game, to go with the fast breaking style of play. Winston was the catalyst, averaging 31.1 points, 15 rebounds, 6 assists, 5 steals and 2 blocked shots per game. Teammates Tim Anderson averaged 11.9 per game, Tom Anderson, Aaron Clegg, Cris Burdette and Tay Montgomery all struck for double digits in various games.*

*How do we sum up that team? You could say there was no "I" in the 1991-92 team. Coach Tice instilled in those players one thing. "The Desire to be the Best of the Best". Determination is not enough, you also need education, good planning and execution to succeed in your life's goals.*

### The Red, White, & Knight

Have you ever wondered where we got our colors or name—Red Knight? The first graduating class of Toronto High School chose our school colors, red and white, in 1889. Not until 45 years later did our colors have a meaning. The graduating class of 1934 thought red should stand for loyalty and courage, while white was for purity and honesty. Our school name was dubbed upon us by a Herald Star sports news writer, Bill Workman, in 1930, when Toronto was playing one of the first ever "Knight" games in the state of Ohio.
